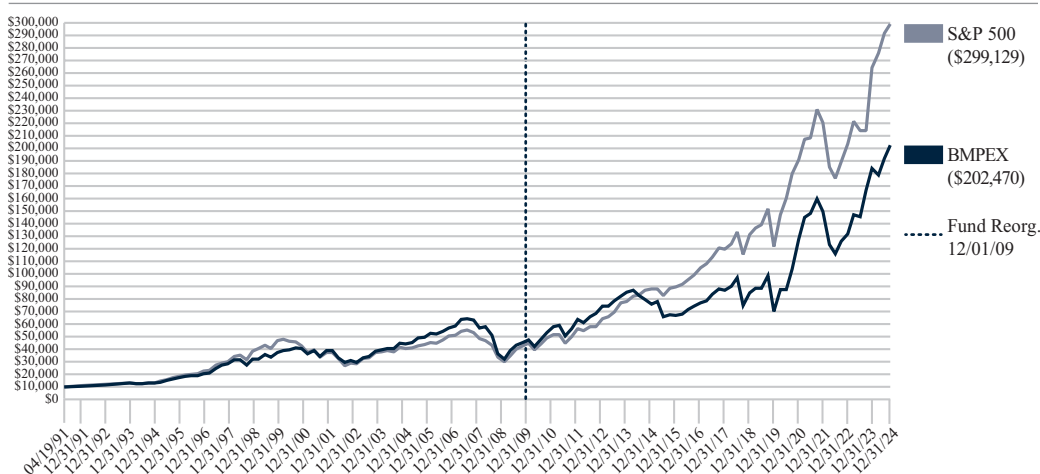

However, the Fund's adviser has contractually agreed to waive its fee and/or reimburse Fund expenses to limit total operating expenses to 1.00% through at least July 31, 2025, otherwise performance shown would have been lower. Shares redeemed or exchanged within 60 days of purchase will be charged a 2.00% fee.

In November 2009, a limited partnership managed by Beck Mack + Oliver reorganized into the Fund. The Fund has adopted the performance history of the limited partnership. The Fund's performance for periods prior to December 1, 2009 is that of the limited partnership and reflects the expenses of the limited partnership, which were lower than the Fund's current net expenses, except for 2008 where the expenses of the limited partnership were higher. The performance prior to December 1, 2009 is based on calculations that are different than the standardized method of calculations accepted by the SEC. If the limited partnership's performance had been readjusted to reflect the estimated expenses of the Fund for its first fiscal year, the performance would have been lower. The limited partnership was not registered under the Investment Company Act of 1940 ("1940 Act") and was not subject to certain investment limitations, diversification requirements, and other restrictions imposed by the 1940 Act and the Internal Revenue Code of 1986, which, if applicable, may have adversely affected its performance.
